# 1.0 INTRODUCTION

The proposed contract will commence in 2024 and remain active for five-year duration, followed by two-year extension option.

## 2.0 SCOPE OF WORK

Scope of activities under this contract include the following:

#### MODULE 1: GEOPHYSICAL ACQUISITION SUPERVISION SERVICES

- Supervision by experienced seismic data acquisition consultants (Geophysical, Geomatics, HSE, Security and Community Affairs) of seismic operations as well as reporting and monitoring of performance.
- Provision of Quality Assurance and Quality Control (QA/QC) services during seismic data acquisition campaigns using the necessary tools/equipment.
- Ensuring that all HSSE & SP standards are complied with, as defined in the contract between SPDC and the geophysical contractor, or otherwise agreed upon between SPDC and the geophysical contractor.

#### MODULE 2: GEOPHYSICAL DATA CENTRE MANAGEMENT AND **OPERATIONS SERVICES**

- Provision of 24/7 operational support for the Special Geophysics Computing Data Centre facility located in Port Harcourt.
- Monitoring the IT hardware devices (i.e. the Server, Storage, Network and tape drives racks equipment) and Utilities in the facility (such as temperature/humidity values, detection/suppression system, Power Management Module).
- Manage seismic tape request of all active special geophysics projects (loading and offloading archiving/de-archiving and accurate labelling of tapes).
- · Provision of routine seismic tape drive maintenance services and first-hand interface with OEM for software upgrades and major repairs.
- Provision of seismologist services and seismic data QAQC.

All services will be delivered by Nigerians, and all spend is in Naira.

## 4.0 NIGERIAN CONTENT REQUIREMENTS

4.0 Nigerian Content Requirements

Vendors are to demonstrate strict compliance with the provisions of Nigerian Oil & Gas Industry Content Development Act and provide the following requirements:

- 1. Tenderer shall provide evidence of being a Nigerian indigenous company having more than 51% of Nigerian equity shareholding in the registered entity. Tenderer shall submit certified true copies of CAC forms 10, 02 and 07.
- II. Tenderer shall provide evidence of registration on the NCDMB NOGIC JQS; NUPRC Permit, etc.
- III. Tenderer shall provide evidence of Category 1,2,3,4 or 5 Consultancy Services (CS) group NCEC demonstrating capacity and capability to execute seismic acquisition supervision services and Geophysical data center management and operation services in accordance with the NCDMB published NCEC guideline.
- IV. Provide evidence of what percentage of your key management positions is held by Nigerians and what percentage of the total work force are Nigerians. Also, show overall percentage of work to be performed in Nigeria and those by Nigerian resources relative to total work volume.
- V. Tenderer shall provide detailed description of the location of in-country committed facilities & infrastructure (not limited to technical office, and administrative space) in Nigeria to support this contract.
- IV. Comply with the latest approved version of NCDMB HCD guideline by committing (via a letter of undertaking) to providing Project-Specific training, man-hour, budget, skill development and understudy plan for Nigerian personnel utilizing OGTAN registered trainer(s) or other approved NCDMB training institution(s).

# 5.0 CLOSING DATE

Only Tenderers who are registered in the relevant NJQS product categories as at 02/09/2024 being the advert close date shall be invited to submit combined Technical and Commercial bids at the same time.
